**Who we are and how to contact us.** Our website is operated by Tierna Byrne trading as Tierna Byrne Marketing & Design (“we”). Our main trading address is in Belfast, Northern Ireland.

**By using our website you accept these Terms.** By using our website, you confirm that you accept these Terms and that you agree to comply with them. If you do not agree to these Terms, you must not use our website. We recommend that you print a copy of these Terms for future reference.

**There are other terms that may apply to you.** These Terms refer to the following additional terms, which also apply to your use of our site:

- our [Privacy Policy](#), which sets out how we deal with your personal data;
- our [Cookie Policy](#), which sets out information about the cookies we use on our website.

**We may make changes to these Terms.** We amend these Terms from time to time. Every time you wish to use our website, please check these Terms to ensure you understand the terms that apply at that time. These Terms were most recently updated in August 2023.

**We may make changes to our website.** We may update and change our website from time to time to reflect changes to our products or services, our users’ needs and our business priorities.

### **Our responsibility for loss or damage suffered by you**

You also agree not to access without authority, interfere with, damage or disrupt:

- any part of our website;
- any equipment or network on which our website is stored;
- any software used in the provision of our website; or
- any equipment or network or software owned or used by any third party.

You agree that you are using our website, its content and any digital products purchased or downloaded via our website for your private, non-commercial use only. You further agree that you will not redistribute, transmit, assign, sell, rent, exchange, commercially exploit, broadcast, modify, adapt, copy, edit, sub-licence, share, lend, or transfer any part of our website, its content or any digital products purchased or downloaded via our website unless agreed with us in writing.

**Interactive Services.** We may from time to time provide interactive services on our website, including, without limitation:

We will determine, in our absolute discretion, whether a Contribution breaches the Content Standards.

A Contribution must:

- be accurate (where it states facts);
- be genuinely held (where it states opinions);
- comply with the law applicable in the United Kingdom and in any country from which it is posted.

A Contribution must not:

- be defamatory of any person;
- be obscene, offensive, hateful or inflammatory;
- promote sexually explicit material;
- promote violence;
- promote discrimination based on race, sex, religion, nationality, disability, sexual orientation or age;
- infringe any copyright, design right, database right, trade mark or other intellectual property right of any other person;
- be likely to deceive any person;
- breach any legal duty owed to a third party, such as a contractual duty or a duty of confidence;
- promote any illegal activity;

- be in contempt of court;
- be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety;
- be likely to harass, upset, embarrass, alarm or annoy any other person;
- impersonate any person, or misrepresent your identity or affiliation with any person;
- give the impression that the Contribution emanates from us or our company, if this is not the case;
- advocate, promote, incite any party to commit, or assist any unlawful or criminal act such as (by way of example only) copyright infringement or computer misuse;
- contain a statement which you know or believe, or have reasonable grounds for believing, that members of the public to whom the statement is, or is to be, published are likely to understand as a direct or indirect encouragement or other inducement to the commission, preparation or instigation of acts of terrorism;
- contain any advertising or promote any services or web links to other websites.

**Breach of this Policy.** When we consider that a breach of this Acceptable Use Policy has occurred, we may take such action as we deem appropriate. Failure to comply with this Acceptable Use Policy constitutes a material breach of the Terms upon which you are permitted to use our website, and may result in our taking all or any of the following actions:

- immediate, temporary or permanent withdrawal of your right to use our website;

**Which country's laws apply to any disputes?** If you are a consumer, please note that these Terms, their subject matter and their formation, are governed by the laws of Northern Ireland. You and we both agree that the courts of Northern Ireland will have exclusive jurisdiction, except that if you are a resident of England and Wales you may also bring proceedings in England and Wales, and if you are a resident of Scotland, you may also bring proceedings in Scotland.

If you are a business, these Terms, their subject matter and their formation (and any non-contractual disputes or claims) are governed by the laws of Northern Ireland. We both agree to the exclusive jurisdiction of the courts of Northern Ireland.
